

FOR EFFECTIVE SORTING, EVERY ACTION COUNTS

Do you know about sorting rejects? **These are waste items placed in sorting containers by mistake, which cannot be recycled due to their material or composition.**

Did you know? **In 2025, in the Pays de Gex territory, 28% of the waste deposited in yellow bins was non-compliant.** These errors represent an environmental cost and an additional cost (collection and sorting) for the community. These errors force nearly a third of the waste from yellow bins to be rerouted to incineration, canceling out the sorting effort.

To be properly sorted, **recyclable packaging must meet four essential conditions: it must be packaging, empty, not nested (inside one another), and thrown in loose**



THE MOST COMMON SORTING ERRORS IN THE YELLOW BIN, TO REMOVE ALL DOUBT!



Do not put everyday plastic objects in the bin



No glass bottles



No hygiene waste or textiles



Packaging must be emptied and separated from one another



Items destined for the yellow sorting bin must not be bagged



No electronic or electrical devices



BULKY WASTE: HAVE THE RIGHT REFLEX!



To get rid of a sofa, a refrigerator, or any other bulky item, some solutions exist:

HOUSEHOLD WASTE COLLECTION



Please put your bin out **the evening before your collection day.**




A bin which has been overfilled or with bags next to it **counts as 2 collections.**




Please do not leave bags, bulky items or cardboard boxes next to the container; **doing so may result in a fine and clean-up costs.**

ADMINISTRATIVE PROCEDURES



Notify us quickly, with the necessary supporting documents, **so that your account can be closed.** The bill for the outstanding balance will be sent to your new address. **The bin and/or badges should be left in the property you're leaving.**



Notify us as soon as possible, **even if it's within the same commune, in order to open an account for the new address,** check what equipment is already there (bin and/or badges) and activate them for future collections.
